4.1 Residential Homes Consultation

Councillor McNamee advised members that a meeting had been held on 10 February 2014 in Westlands Home with representatives from Council, Mark Conway, Westlands' residents, their families and staff to discuss the Health and Social Care Board's current consultation regarding the proposed criteria to be used to decide the future of Residential Homes. Council will be submitting a response to this Consultation and was keen to get input from those personally affected to incorporate within Council's Response

4.2 Davagh Forest

Councillor Clarke advised members that at the PCSP meeting on 23 January 2014 he had advised the PSNI that that in February 2013 there was a serious disturbance in Davagh Forest with approximately 500 cars convening there on a Sunday night and staying until the early hours of Monday morning. He said that according to the local press the same was planned for 9 February 2014 with cars meeting at the Crevenagh Road "Park and Ride" in Omagh before heading to Davagh Forest. Councillor Clarke stated that at that meeting he asked the PSNI if plans would be put in place to re-direct these people and Inspector D Walsh replied that as they were now aware of the situation they would be dealing with it. However, on the night of the 9 February 2014 locks had been broken and entry made to Davagh Forest Park and damage caused.

Members AGREED that a meeting with the PSNI should be arranged to discuss this matter.

The Deputy Director of Corporate & Operational Services outlined the net cost of the various services and clarified points raised regarding items of expenditure.

On the proposal of Councillor McGarvey seconded by Councillor Clarke it was proposed that the estimated net cost of £9,838,655 be approved for the forth coming year commencing 1 April 2014 with the deduction of General Grant of £1,476,227. The Non Domestic District Rate of 22.7390p and the Domestic District Rate of 0.2879p be determined as the rates to be levied to meet the estimated expenditure. This represents an increase to the District Rate of 0.9%.

On the proposal of Councillor Wilson, seconded by Councillor Glasgow it was proposed that a 0% is applied.

Following a show of hands 6 members voted for the substantive motion and 10 members against.

Following a show of hands 10 members voted for the original motion and 6 members against.

The Chairman declared the original motion carried and the increase of 0.9% is applied.

10.2 Western Group Building Control Committee estimated expenditure 2014/2015

On the proposal of Councillor Glasgow seconded by Councillor Mallaghan members AGREED that the estimate of £28,020 is adopted.
