1.1	To confirm the appointment of Mid Ulster Policing and Community Safety Partnership Chair from June 2018 (Council AGM) to the date of Mid Ulster District Council's AGM 2019.

2.1	In accordance with the Justice (Northern Ireland) Act 2011, Part 3, Schedule 1, Section 10, for each PCSP there shall be a Chair appointed by the Council from among the political members. In appointing the Chair, the Council shall ensure that, so far as practicable a person is appointed to that office for a term of 12 months at a time. The office is to be held in turn by each of the four largest parties represented on the council immediately after the last Local Election.

3.1	With reference to 2.1 (above) Sinn Fein held the position of Chair during 2015/2016, the DUP held the Chair in 2016/2017, UUP held the Chair in 2017/2018. It is now the turn of the SDLP to take the position of Mid Ulster Policing and Community Safety Partnership Chair for 2018/2019.
