The meeting started at 7.35 pm

1 EXPRESSION OF SYMPATHY

The Mayor referred to the death of the brother of Councillor Molloy and expressed sympathy with the family.

He also referred to a fatal road accident involving three members of the Maughan family from Coalisland and Mr Peter McArdle from Moy killed as result of a motorcycle accident. He expressed the sympathy of the Council to all those bereaved.

<u>Resolved</u> That letters of condolence be sent to the bereaved families.

Councillor Molloy thanked the Council for the expression of sympathy.

2 MINUTES – COUNCIL - 12 AUGUST 2002

The Mayor advised that two motions challenging the accuracy of the Minutes had been received.

Councillor McGuigan in proposing the undernoted motion stated that he did so having regard to standing orders 7 and 9.2b. He further stated that the motion was self-explanatory and decision taken by Mayor to refuse adjournment was illegal and any decisions taken after that time should be declared null and void.

"The decision taken by the Mayor alone to refuse an adjournment was illegal and thus any decisions taken after this point should be declared null and void. Secondly there is a matter of the serious inaccuracy of the delayed minutes of this meeting."

Under Standing Order 7, "Any meeting of the Council which has lasted continuously for four hours shall stand adjourned unless two thirds of the members of the Council present shall by resolution determine to continue the sitting."

According to page C16 16.1 we would have required this to have happened that night. Since the eight Sinn Fein members (38%+ on the night) were calling for an adjournment it should have been impossible for it to have continued.

Under Standing Order 9.2b there are a number of serious inaccuracies in the minutes.

Page C1 states "the meeting started at 7.45".

Page C17 says "the meeting started at 7.30 and ended at 12.00".

Finally C16 16.1 states that "the meeting having lasted continuously for four hours and that it was past 11.30 the meeting should stand adjourned".

Councillor Monteith seconded the motion.

The Mayor, Councillor Cavanagh, referred to an omission in the minutes and wished the undernoted to be added to the minutes of the 12 August meeting.

'At 11.28 pm on Monday 12 August I, as chairman, commenced reading a letter from NIO. The letter concerned the status of district policing and legal opinion on the issue of personal liability. Before I started to read, I said to the meeting that it was now 11.28, 2 minutes short of the time when we would have to seek leave from the members to continue with the meeting.

When I finished reading, the question arose as to whether the 11.30 had by then been reached.'

Considerable discussion ensued in relation to standing orders, the timing of the meeting and the validity of decision taken after 11.30 pm on the 12 August 2002. A number of members felt that standing orders should have been followed and counter proposal calling for the meeting to be adjourned should have been put to the meeting. Others stated that custom and practice within the Council showed that down the years, through the leniency of the Chairman, standing orders are broken time after time.

The Mayor, Councillor Cavanagh stated that there was no intention on his part to abuse standing orders throughout that night or to deny the democratic right to anyone.

Proposed by Councillor Daly Seconded by Councillor Hamilton

That minutes be amended to include omission as outlined by Councillor Cavanagh.

Councillor Daly's proposal being put to the meeting 9 (nine) members voted in favour and 8 (eight) against.

Councillors Maginnis and Morrow arrived at 7.55 pm.

Further discussion ensued when the comments made earlier were reiterated.

Councillor Molloy asked the record to show that Chairman regularly set aside standing orders to keep the meeting flowing but that the Local Government Act actually states that have to have motion to continue after four hours.

Councillor McGuigan's proposal being put to the meeting 8 (eight) members voted in favour and 12 (twelve against).

The Mayor declared

The proposal being put to the meeting 13 (thirteen) members voted in favour and 8 (eight) against.

11 NOTICE OF MOTION COUNCILLOR MAGINNIS

Councillor Maginnis in proposing the undernoted notice of motion spoke of the need to create an awareness, the need for a proper picture to be painted to see what are the treats to parental control and to make parents aware of what is happening to their children.

'In the light of the Government programme to halve teenage pregnancies over the next 10 years we request the (Southern) Health & Social Services Board to collate and publish the following information for each Borough/District Council area falling within its bailiwick for the years 1999, 2000 and for each subsequent year as data becomes available:

- The number of facilities offering family planning services aimed at young people under the age of 20, including the number of schools (if any) and pharmacies, providing the 'morning-after-pill' to undersixteens.
- The estimated cost of providing such services.
- The number and rates of teenagers attending family planning clinics by age and sex.
- The number and rates of teenagers, by age and sex, being provided with condoms through:

- a. family planning clinics
- b. schools
- The number and rates of teenagers, by age, being provided with the 'morning-after-pill at:
 - a. clinics
 - b. pharmacies
 - c. schools
- The number, and rates by age, at conception, of
 - a. all teenage pregnancies
 - b. teenage abortions known to be carried out outside Northern Ireland
- The incidence, and rates by age and sex, of sexually transmitted infections among teenagers.'

The motion was seconded by Councillor Currie.

A number of members spoke in favour of the motion.

The motion was put the meeting and unanimously adopted.

12 NOTICE OF MOTION COUNCILLOR MOLLOY

Councillor Molloy in proposing the undernoted notice of motion spoke of the support of the Council's representatives on the Southern Education and Library Board in having the decision to withdraw concessionary bus services rescinded. He stated that this was a temporary decision and if the service was withdrawn it would have a detrimental effect on rural schools, there was a need to protect this vulnerable section of the community and the need for equality of access for those in rural areas.

This Council welcomes the decision to rescind the withdrawal of concessionary bus services by the SELB. We would now call on the Minister for Education to implement a free bus service for all children living within rural communities, given the clear lack of alternative options, the poor road conditions and lack of street lighting it is unsafe and impractical for children to have no transport system. The Minister should fully consider the distinct rural issues which affect this matter and use rural proofing as a key in determining the best mechanism for providing equality of access for those in rural areas.'

The motion was seconded by Councillor Currie.

Councillor McIlwrath a representative on the Southern Education and Library Board stated that he did not support the recinding of the decision as officers of the board had met with the Minister and Education Committee to ask for a fairer allocation of monies to provide essential services and they had not been successful. Due to pressures on available finance he could not support the motion as he felt it was superficial and impractical.

Councillor Monteith a representative on the Southern Education and Library Board stated that he had supported the rescinding of the decision and felt that it was important that the matter should be highlighted to the Minister and he should be requested to initiate a change to legislation in relation to two mile limit.

The motion was put to the meeting 17 (seventeen) voted in favour and 1 (one) against.

The Mayor declared the motion carried.

13 NOTICE OF MOTION COUNCILLORS GILLESPIE AND DONNELLY

Councillor Gillespie in proposing the undernoted notice of motion spoke of the inconvenience in having the Council district split between two administration centres and the inconvenience to the electorate in the torrent area in having a round trip of 140 miles to transact business.

'This Council is dissatisfied with the recent decision of the Chief Electoral Officer in regard to the changes of the Electoral Office area of responsibility. We do not believe that this move which places the Torrent Valley area under the responsibility of the Ballymoney office is in the best interests of the electorate of the District. We are opposed to this decision and ask that the Council write to Mr Denis Stanley, Chief Electoral Officer for the decision to be reversed. We also request that a delegation meet with Mr Des Browne MP the Minister responsible for this area to impress upon him our case.'

Councillor Donnelly seconded the motion.

A number of members spoke in support of the motion and the further erosion of services in the West of the province.

The motion was put to the meeting 18 (eighteen) voted in favour and none against.

The Mayor declared the proposal carried.
