On the proposal of Councillor Greer, seconded by Councillor Parke it was AGREED to accept the above mentioned tenders.

11.2 Mid Sports Ulster Complex

Mr Brian Laverty of Doran Consulting was in attendance. The Chief Building Control Officer's Report had been circulated previously and Doran Consulting's Report and Recommendation in relation to tenders received was circulated at the meeting.

The lowest tender adjusted to take account of arithmetical errors was submitted by P T McWilliams Contracts in the sum of £1,833,306.15.

Mr Lavery reported that he had received written confirmation from this firm that their tender will hold for the supply and installation of a synthetic pitch which fully complies with the specification.

It was noted that in order to provide a contingency of £90K as per the pre-tender estimate it would be necessary to add an additional £70K to the tender sum. Furthermore the estimated costs for re-routing NIE cables is estimated to cost £21K.

The Chief Building Control Officer provided details of a financial appraisal that indicated that the total funding currently available for the project is £2020K. The projected costs of the project taking into account the additional sums for contingency, NIE works and additional fees is £2108K that is £88K over the total currently available. It is apparent therefore that if the contingency as envisaged is expended either additional funds will have to be made available or savings by way of alterations or omissions to the works will be necessary. The Chief Building Control Officer suggested that decision in relation to this matter could be taken as the project progresses when the position in regard to expenditure of contingencies becomes clearer.

On the proposal of Councillor McGarvey seconded by Councillor Greer the Council AGREED to accept the tender submitted by PT McWilliams Contracts in the adjusted tender sum of £1,883,306.15 subject to the following provisos:

1. Doran Consulting should inform the Contractor that the Council has a strict budget for the project, which must not be exceeded, and hence it is likely that significant savings by way of alterations or omissions to the works will be necessary.
2. Doran Consulting will be required to exercise strict financial control of the project in order to ensure the minimum expenditure of contingencies and will be required to provide to the Council regular financial appraisals of expenditure.
