## **6 Building Control Department**

The Director of Building Control presented the Department's report for the period 1 August to 31 August 2014 (copy previously circulated to each Member).

6.1 During this period 1 August to 31 August 2014 twenty-six applications had been recommended for approval. A total of eighty applications required amending by Architects and Agents before granting approval.

### **6.2 Building Regulations Inspections**

During the period from 1 July 2014 to 31 July 2014 seventy-one applications commenced on site and sixty-seven applications were found to be complete in accordance with Building Regulations.

The department carried out two hundred and seventy inspections during this month.

### **6.3 Naming and numbering of Streets**

Mr Glendinning further reported that the new synthetic pitch at Meadowbank was now the only pitch in Northern Ireland and Southern Ireland certified to the highest standards for all three sports disciplines of –

Football – FIFA 2-star certified  
Rugby – IRB Certified List  
GAA – 2009 Performance Standard

**Councillor J Campbell** commented that this was quite remarkable and said that it was a credit to all involved in the planning and development of the synthetic pitches at Meadowbank. The district of Magherafelt now had a sports field playable by all three disciplines at a quality of which was best in Ireland and that others should take account of the high standards.
