3 REPORT OF HEAD OF LEISURE SERVICES

3.1 Household Membership

The Committee RECOMMENDED that household membership should be introduced and also be made available at other Sport and Leisure facilities in Mid Ulster, to be introduced in April 2015 as part of an overall Mid Ulster Leisure Services Membership package.

3.2 Climbing Wall
